## PRESS RELEASE –

### Q2–FY2023 RESULTS OF THE COMPANY

- Q2 is one of our weakest quarters due to the onset of the monsoon and other religious festivals which hamper sales. **Our company has reversed the trend and posted encouraging results which have set a trend for the remaining part of the financial year.**
- Our Q2 FY 22-23 consolidated income stood at Rs. 147.86 crores for the FY 22-23 as compared to Rs.78.32 crores in the same quarter of the FY 21-22; a growth of 89%. Our Q2 total income for FY 22-23 has increased by 80% over the same period in FY 19-20 which was our best year pre-covid.
- Our EBIDTA for the Q2 FY 22-23 was at Rs 18.62 crores as compared to Rs.5.51 crores for the same period last year a growth of 238 %.
- Our PAT for the Q2 FY 22-23 stood at Rs.8.26 crores as compared to the Q2 loss of Rs.2.50 crores; reflecting a complete turnaround.
- Our PAT for the Q2 FY 22-23 is even up 230% as compared to the PAT reported in the Q2 FY 19-20 which was our best performing pre-covid year.

### HALF YEARLY FY2023 RESULTS OF THE COMPANY

- For the 1st HY 22-23 our net income stood at Rs. 403.95 crores as compared to the net income of Rs. 128.97 crores for the HY 21-22 a growth of 213%. We have already surpassed the net sales of the last full financial year.
- For the 1st HY 22-23 our net sales are up 50% as compared to the 1st HY sales of FY 19-20 which was the pre-covid year.
- For the HY 22-23 our EBIDTA was at Rs.54.51 crores at a margin of 13.5% as compared to Rs. 1.10 crores for the HY 21-22 a growth of 4878%.
